Promotion Terms and Conditions

Promotion Eligibility

To be eligible for the promotion, the buyer (Eligible Buyer) must meet the following conditions:

- 1. Be a natural person over the age of 18, and not a company, registered builder, superannuation fund, or acting as an agent for another party.
- 2. Not be referred to Goldfields or Winterfield by a referring channel agent.
- 3. Not be an employee, agent, consultant, or related entity of Goldfields.
- 4. Enter into an unconditional contract of sale with Goldfields for the purchase of an Eligible Property (Contract) during the promotion period
- 5. Comply with the terms of the Contract and not be in default under the Contract.
- 6. Settle the acquisition of the Eligible Property on the required settlement date

Rebate Eligibility and Amounts

The promotion includes a rebate for Eligible Buyers who purchase properties in selected stages, as follows:

- 3. The Eligible Buyer forfeits the right to receive the Promotion if they fail to comply with any terms of the Promotion or their Contract.
- 4. The Promotion cannot be used in conjunction with any other promotion or campaign by Goldfields.
